- That you were not the driver, or the person in charge of the vehicle at the time of the alleged offence.
- If you are unable to provide full details, you as the registered owner of the vehicle are deemed to have committed the offence.
- If the vehicle was stolen, or being used unlawfully at the time of the alleged offence, then you should provide supporting documentation (eg Police offence report) as to the identity and address of the person who was the driver or person in charge of the above vehicle at the time of the alleged offence.
- You sold the vehicle prior to the date of the alleged offence. (NOTE: STATUTORY DECLARATION OVERLEAF).
